ARTICLES OF ORGANIZATION OF OASIS BAYSHORE DEVELOPMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Elorida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME
