ON THIS DAY, personally appeared before, the undersigned authority, duly authorized to administer oaths and to take acknowledgements, BERNARD A. LEBEDEKER, ESQ., ("Affiant") who, after being duly sworn, upon his oath deposes and says:

- I am the past registered agent of the Florida limited liability company, XLP, LLC
 (Document Number L22000505382) which was registered on November 30, 2022.
- 2. My entity, Benny Lebedeker, LLC, was an owner of XLP, LLC, and my co-owners and co-Managers in that entity were Jeffrey C. Pepin, P.A. and Dean T. Xenick, P.A..
- Each of these three entities are the solely owned entities of my law partners, Jeffrey
 Pepin, Dean T. Xenick, and myself.
- 4. Mr. Pepin, Mr. Xenick, and myself, were law partners in the firm known as Justus Reid & Associates, LLC (Document Number L12000022958), along with the then-owner and Manager, Justus W. Reid.
- 5. The principal and mailing addresses for both Justus Reid & Associates and XLP, LLC were the same as XLP was an entity created by Mr. Xenick, Mr. Pepin, and myself while we were working for Justus Reid & Associates.
- 6. On August 25, 2023, Mr. Xenick, Mr. Pepin, and myself, completed a membership interest buyout of Justus Reid & Associates, LLC whereby we purchased the entirety of Mr. Reid's membership in the firm so that we are now the only three owners of Justus Reid & Associates. LLC.
 - 7. Subsequently, in order to keep the same EIN number, same bank accounts, and the

same insurance plans for our employees, we decided to voluntarily dissolve XLP, LLC on August 29, 2023, and then file an Amendment to the Articles for Justus Reid & Associates, LLC, showing the new Managers and Registered Agent for the entity, and also changing the name of the entity to the name that we want, XLP, LLC (which we had just voluntarily dissolved.

- 8. As we were the individuals who dissolved XLP, LLC, we have no intention of reinstating that separate entity, as we now wish to simply rename the Justus Reid & Associates, LLC entity to XLP, LLC.
- 9. As such, there should be no issue with accepting the Amendment that is currently under review with the State of Florida.
- 10. The notarized signatures of Mr. Xenick and Mr. Pepin are hereby affixed to this Affidavit below as well.




