ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF KAPEX HOLDINGS, L.L.C.

The following Article V is hereby added to the Articles of Organization of the limited liability company:

ARTICLE V - Membership Units:

The Company will have two classes of Membership Interests, being Class A voting Membership Interests and Class B nonvoting Membership Interests. There will be 1 authorized Class A voting Membership Interest, and 99 authorized Class B nonvoting Membership Interests. Each Membership Interest will have the same rights as to percentage ownership and for all other purposes, except that only the Class A Membership Interests will have the right to vote.
