Thank you for helping resolve the filing issues for the above-captioned Limited Liability Company.

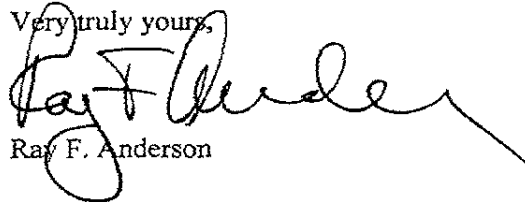
As you are aware, it has been rejected because I had voluntarily dissolved my PA (P02000011577) of a similar name and I need to verify this by virtue of this letter.
