
**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
BLINC AGENCY, LLC**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **BLINC AGENCY, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 608.411:

1. Name of Company. The name of the Company is **BLINC AGENCY, LLC**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization with the Florida Department of State with an effective date of February 22, 2012 (the "Articles").
3. Amendment to Articles of Organization. Paragraph 6 of the Company's Articles is hereby amended by deleting the current text of Paragraph 6 in its entirety and substituting the following in lieu thereof:
