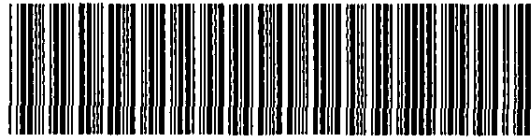


#### ARTICLE IX - MEMBERS' RIGHT TO CONTINUE BUSINESS
