




Transfer of ownership of Champion Electrical Solutions, LLC From Noel Funelas to Stephen Champion Jr.

Date 2/13/15

It shall here by be known that Noel Funelas is releasing his ownership of Champion Electrical Solutions, LLC hereafter refered to as "The Company" to Stephen Champion. In the sad state that The Company has a debt at this point Stephen Champion will assume all debt burden previous, current, or future that may be incurred by The Company and hold Noel Funelas Harmless and not pursue for any debt incurred by the company. In exchange for the release of liability from the company's debt or any other liability incurred, noel Funelas shall pay to Stephen Champion the sum of \$35,000.00. Noel funelas agrees to pay monthly payments no less than \$400, and agrees to pay debt in full within (6) six years of the date of this signature. Payments shall start no later than april 2015 and shall continue on a timely manner until debt is paid. This agreement shall take priority over all other agreements prior to it.
