**ARTICLES OF ORGANIZATION
OF
MARILYN'S TOFFEE AND MORE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Marilyn's Toffee and More, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 7322 Manatee Avenue West, #300, Bradenton, Florida 34209-3441.

ARTICLE II

PURPOSES AND POWERS

member. The Company shall be terminated and dissolved upon the consent of all of the members.

ARTICLE VI

MANAGER


The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company.
