The undersigned hereby certifies that he is the Authorized Representative of the Member who is forming a Professional Limited Liability Company under Chapter 621, Florida Statutes. following Articles of Organization are hereby adopted.

ARTICLE I. NAME

The name of the Professional Limited Liability Company shall be Florida Dermatology and Skin Cancer Specialists, P.L.

ARTICLE II. DURATION; EFFECTIVE DATE
