The undersigned hereby certifies that he is the Authorized Representative of the Member who is forming a Professional Limited Liability Company under Chapter 621, Florida Statutes. The following Articles of Organization are hereby adopted.

ARTICLE I.
NAME

The name of the Professional Limited Liability Company shall be Florida Dermatology and Skin Cancer Specialists, P.L.

ARTICLE II.
DURATION; EFFECTIVE DATE

This Professional Limited Liability Company shall exist perpetually, commencing as of February 21, 2012.

ARTICLE III.
ADDRESS; PRINCIPAL OFFICE

The mailing address and the street address of the Professional Limited Liability Company is 4915 Ehrlich Road, Tampa, Florida 33624.

ARTICLE IV.
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the Professional Limited Liability Company is 360 Central Avenue, Suite 1200, St. Petersburg, Florida 33701 and the name of its initial registered agent at such address is Thomas B. Smith.

ARTICLE V.
PURPOSE

This Professional Limited Liability Company is organized for the following purposes:

A. To engage in every aspect of the practice of medicine and the performance of services ancillary thereto.

B. To render professional services in connection with the practice of medicine by and through its officers, employees, and

agents who are duly licensed or otherwise legally authorized to render such professional services within the State of Florida.

C. To invest its funds in real estate, mortgages, stocks, bonds and any other types of investments permitted by law.

D. To own real and personal property necessary for the rendering of professional services authorized under these Articles of Organization.

E. To engage in no other business.

F. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the above described purposes, either alone or in association with others, including matters incidental or pertaining to, or connected with such purposes, provided the same shall not be inconsistent with the laws of the State of Florida.


ARTICLE VI
RESTRICTIONS ON MEMBERSHIP;
RIGHT TO ADMIT ADDITIONAL MEMBERS

Members must be licensed to medicine or osteopathy in the State of Florida, or professional limited liability companies whose owners are all licensed to practice medicine or osteopathy in the State of Florida. A member's interest in the Professional Limited Liability Company may not be sold or otherwise transferred except to a person licensed to practice medicine or osteopathy in the State of Florida and only in accordance with the provisions of the Operating Agreement of this Professional Limited Liability Company.

The undersigned, being the Authorized Representative of the Member of the Professional Limited Liability Company, hereby certifies that the foregoing constitutes the Articles of Organization of Florida Dermatology and Skin Cancer Specialists, P.L.
