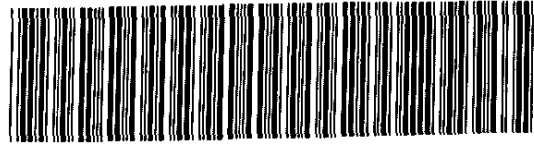

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

**ARTICLE I**

*Name and Address of Company*

The name of the limited liability company is TC9008, LLC. The Company's street address and mailing address is 1350 Market Street, Tallahassee FL 32312.

**ARTICLE II**

*Commencement and Duration of Company*

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all of the remaining members.

**ARTICLE III**

*Management*

William D. Crona., with offices at 1350 Market Street, Tallahassee FL 32312 shall serve as the Company's initial Manager until the first annual meeting of the membership or until its successor is elected and qualified. Thereafter, the Company will be managed by a manager or managers elected annually, as provided in the Company's regulations.

*Admission of Additional Members*

This is a single member limited liability company and additional members will not be admitted to the Company.

**ARTICLE V**

*Termination of Membership*

This is a single member limited liability company and, if the member of the Company ceases to exist, the Company will be wound-down and dissolved in accordance with the Florida Limited Liability Company Act.

### *Registered Agent and Office*


The Company's initial registered agent is William D. Crona and the street address of the Company's initial registered office is 1350 Market Street, Tallahassee FL 32312.
