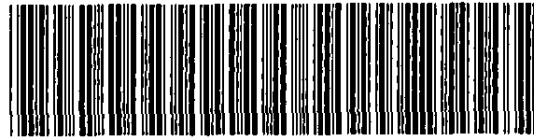

ARTICLE IV - Purpose

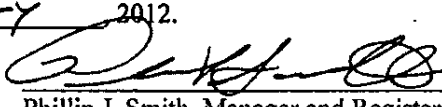
The purpose of this limited liability company is to invest and reinvest its capital for security, growth, income and any other investment and business purposes.

Registered Agent, Registered Office and Registered Agent's Signature

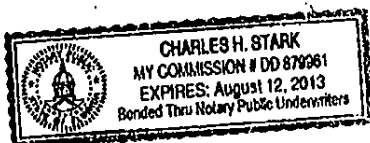
