**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF ORGANIZATION  
FOR  
STERILYFE USA HARRISTEETER ACCOUNT, LLC**

Pursuant to *Section 608.411, Florida Statutes*, the Limited Liability Company desires to amend its Articles of Organization having been filed with the Florida Secretary of State under Document Number L12000028343 on the 28<sup>th</sup> day of February, 2012 (collectively the "Articles of Organization").
