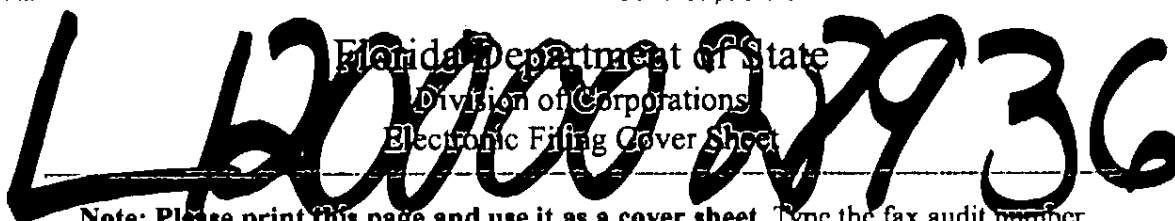

ARTICLES OF DISSOLUTION OF SEARCH2O, LLC

SEARCH2O, LLC, a Florida limited liability company (the "Company"), pursuant to Section 605.0707 of the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Dissolution:

ARTICLE I NAME

The name of the Company is SEARCH2O, LLC. The Articles of Organization were filed on February 28, 2012 and assigned document number L12000028936. The Articles were subsequently amended by those certain Articles of Amendment to Articles of Organization on January 13, 2014.

ARTICLE II EFFECTIVE DATE

ARTICLE III ELECTION TO DISSOLVE

Pursuant to Section 605.0707 of the Act, the Company, by unanimous consent of all members, has elected to dissolve the Company and file these Articles of Dissolution.

All debts, obligations, and liabilities of the Company have been paid or discharged.

ARTICLE V DISTRIBUTION OF PROPERTY

The Company has not acquired any property or assets and therefore distributions were not required.

ARTICLE VI NO SUITS

To the knowledge of the members of the Company, there are no suits pending against the Company in any court.
