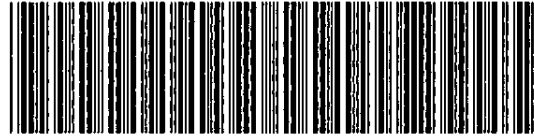

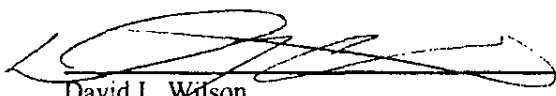
FIRST: The name of the Limited Liability Company is Fleet-One Consulting, LLC.
