**ARTICLES OF ORGANIZATION**  
**OF**  
**GH&G ST PETE, LLC**

The undersigned person, acting as the organizer of GH&G ST PETE, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I - NAME**

The name of this limited liability company is:

GH&G ST PETE, LLC

**ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE**

The existence of the company will commence on March 1, 2012, and the existence of the company shall be perpetual.

**ARTICLE III - PURPOSE**

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

**ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE**

#### ARTICLE IX - TERMINATION OF MEMBERSHIP INTEREST


