ARTICLES OF ORGANIZATION

OF

NEW LEAF LANDSCAPE SOLUTIONS, LLC

The undersigned, Glenn C. Klein, Jr., a natural person competent to contract and a member of New Leaf Landscape Solutions, LLC, hereby presents these Articles of Organization as the Articles of Organization of New Leaf Landscape Solutions, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is New Leaf Landscape Solutions, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address and mailing address of the principal office of the Company is 944-C Rachel Drive, Fort Walton Beach, Florida 32547.

ARTICLE III - PURPOSES AND POWERS

The Company shall have all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, as such chapter presently exists and may hereafter be amended.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

ARTICLE VI - MANAGEMENT

The Company shall be a manager-managed limited liability company and will be managed in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial Manager of the Company are as follows:

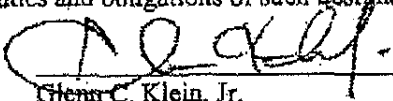
