FIRST: The name of the limited liability company to whom these Articles relate is AXIS RETAIL LLC.

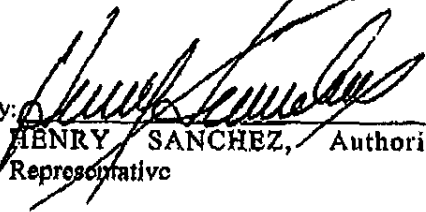
SECOND: Article V of the Articles of Organization are amended to read as follows:
