**ARTICLES OF ORGANIZATION OF  
J & J PROPERTY HOLDINGS OF TAMPA BAY LLC**

The undersigned authorized representative of the members pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby submits the following Articles of Organization:

**ARTICLE I. NAME** - The name of the limited liability company shall be J & J Property Holdings of Tampa Bay LLC (the "Company").

**ARTICLE II. MANAGEMENT** - The initial managers of the Company are Jeffery James Lamm and Jessica Rose Lamm.


