ARTICLE I - Name

ARTICLE IV - Management

The Limited Liability Company is to be managed by its sole Member and is, therefore, a member-managed company.

ARTICLE V - Purpose

The sole Member-Manager of Company is a tax-exempt not for-profit corporation, and the Company shall be operated exclusively for the benefit of the Member-Manager and such purposes as described in Section 501(c)(3) of the Internal Revenue Code, as amended. The objects and purposes to be transacted and carried on are:

- 1) To provide services and support for the Company's sole Member-Manager.
- 2) No part of the earnings of the Company shall inure to the benefit of any Member (unless such Member is exempt from taxation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended), or any other person (except that the Corporation may pay reasonable

compensation for services rendered to or on behalf of the Company and make other payments and distributions in furtherance of one or more of its purposes), and no Member (unless such Member is except from taxation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended), or any other person shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Company.

3) The Company shall not participate, directly or indirectly, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Company shall not have the objectives nor engage in activities which would characterize it as an "action organization" as defined in Treasury Regulation §501(c)(3)-1(c)(3), as it now exists or may be hereafter amended.

4) Notwithstanding any other provision of these Articles, the Company shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and Treasury Regulations thereunder as they now exist or as they may be hereafter amended, or by any organization, contributions to which are deductible under Sections 170(c)(2) and 2055(a) of such Code and Treasury Regulations thereunder as they now exist or as they may be hereafter amended.

5) Upon the dissolution of the Company or the winding up of its affairs, all of the assets of the Company shall be distributed to such charitable, religious, scientific, testing for public safety, literary, or educational organizations which then qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as amended, as the Member may direct.
