- 3) The Company shall not participate, directly or indirectly, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Company shall not have the objectives nor engage in activities which would characterize it as an "action organization" as defined in Treasury Regulation §501(c)(3)-1(c)(3), as it now exists or may be hereafter amended.
- A) Notwithstanding any other provision of these Articles, the Company shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and Treasury Regulations thereunder as they now exist or as they may be hereafter amended, or by any organization, contributions to which are deductible under Sections 170(c)(2) and 2055(a) of such Code and Treasury Regulations thereunder as they now exist or as they may be hereafter amended.
- 5) Upon the dissolution of the Company or the winding up of its affairs, att of the assets of the Company shall be distributed to such charitable, religious, scientific, testing for public safety, literary, or educational organizations which then qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as amended, as the Member may direct.
