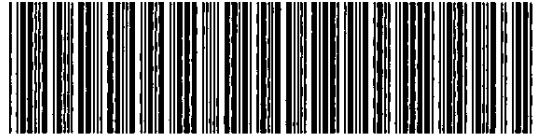



**ARTICLES OF ORGANIZATION
OF
K3 UNDERGROUND, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I. NAME

The name of the limited liability company shall be K3 UNDERGROUND, L.L.C.

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the company is:

ARTICLE III. DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles or organization or in the regulations.

ARTICLE IV. REGISTERED OFFICE AND AGENT

ARTICLE VIII. MEMBERS' RIGHT TO CONTINUE BUSINESS


The company shall be dissolved on the death, bankruptcy, or dissolution of a member or a manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.

ARTICLE IX. MANAGEMENT






