The undersigned, PATRICIA HUBBARD, as the subscriber to these Articles of Organization, hereby presents these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 608.

**ARTICLE I.  
NAME OF LIMITED LIABILITY COMPANY**

**ARTICLE II.
