Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is 115 NW 20th Drive, LLC (the "LLC").
2. The effective date of filing of the Articles of Organization of the LLC was March 9, 2012 (the "Articles").
