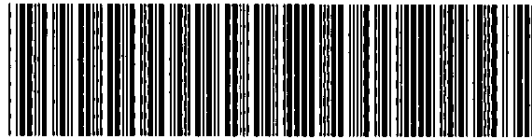

ARTICLES OF ORGANIZATION

ARTICLE VIII - AMENDMENT




