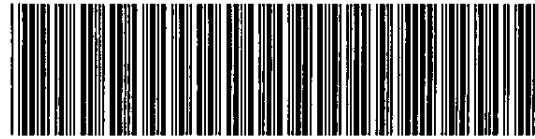



**MEMBERS' RIGHT TO CONTINUE BUSINESS**


