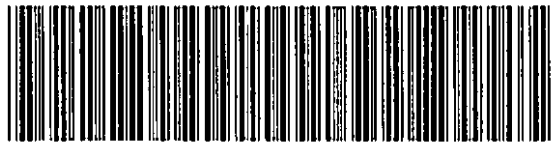

The name of the Florida Limited Liability Company is **Hatcheemar Property, LLC**.






