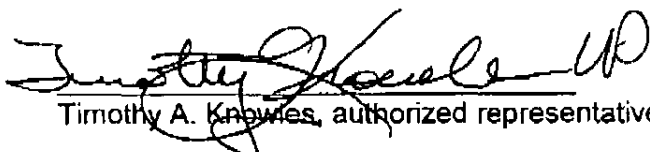

This Company shall indemnify any member, officer, employee, or agent, and any former member, officer, employee, or agent, to the full extent permitted by law.

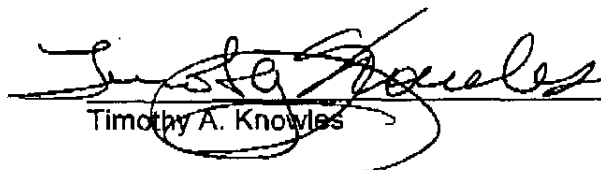

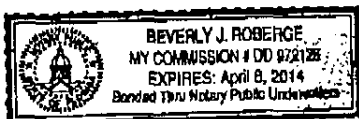
