1. Pursuant to Florida Statutes Section 605.0202, the Articles of Organization of the above-referenced Limited Liability Company is amended in accordance with the following:


FIRST: The date of filing of the articles of organization was March 16, 2012, effective March 16, 2012, under document number L12000037604.


SECOND: The following amendment to the articles of organization was adopted by the limited liability company:
