**ARTICLES OF ORGANIZATION OF

The undersigned authorized agent of the initial members of the limited liability company hereby certifies that the members, for the purpose of forming a limited liability company under the laws of the State of Florida, have directed the execution of these Articles of Organization to provide for the formation, rights, privileges, and immunities of a Florida limited liability company for profit. 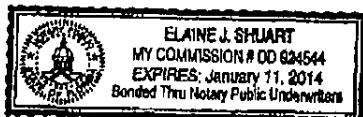
