ARTICLE I
DURATION

KLENK, L.L.C. shall exist perpetually or until dissolved in a manner provided by law, or as provided in the Articles of Organization adopted by the members.

ARTICLE II
NAME AND PRINCIPAL PLACE OF BUSINESS

PURPOSES AND POWERS


The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
