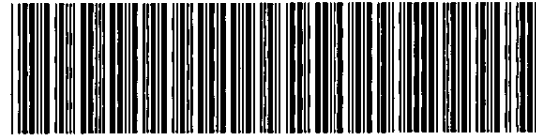

ARTICLES OF ORGANIZATION
OF
JETT METAL PARTNERS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be **Jett Metal Partners, LLC** ("company").

ARTICLE VI – ADDITIONAL CAPITAL CONTRIBUTIONS

ARTICLE X – MANAGEMENT

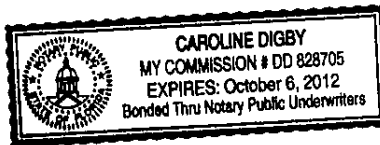

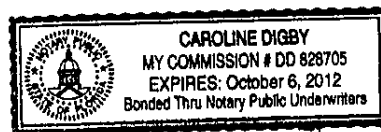
