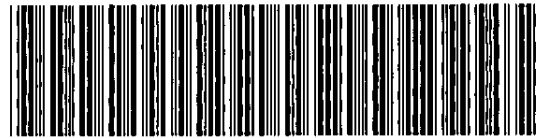

5. The Limited Liability Company is to be managed by a Manager. The name of the initial Manager is: **BALLYBAY CONSULTANTS LIMITED.**


6. The limited liability company will be organized for any and all purposes permitted under Florida Law.
