

ARTICLES OF ORGANIZATION

OF

OTTO GRETA, LLC

ARTICLE I - NAME

The name of the limited liability company shall be OTTO GRETA, LLC (the "Company").

ARTICLE II - MAILING ADDRESS AND STREET ADDRESS

The mailing address and street address of the principal office of the Company is:

ARTICLE III - INITIAL REGISTERED AGENT AND OFFICE

The Company shall have unlimited power to engage in and do any lawful act concerning any or all lawful businesses for which limited liability companies may be organized according to the laws of the State of Florida, including all powers and purposes now and hereafter permitted by law to a limited liability company.
