The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

## ARTICLE 1 - NAME

The name of the limited liability company shall be EMERALD14 LLC ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 17 Harbour Isle Drive West, #405, Fort Pierce, Florida 34949 and the mailing address shall be the same.

#### ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

#### ARTICLE 4 - DURATION

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

# ARTICLE 7 - ADMISSION OF NEW MEMBERS
