AMENDMENT AND RESTATEMENT

OF THE

ARTICLES OF ORGANIZATION

OF

- 1. They are the current Managing Member and Secretary of FOUR BAYS CENTER, LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on March 22, 2012.
