ARTICLES OF ORGANIZATION OF AUERBACH-MYERS NAPLES PARK ONE, LLC

The undersigned authorized agent of the initial member of the limited liability company hereby certifies that the member, for the purposes of forming a limited liability company under the laws of the State of Florida, provided for the formation, rights, privileges, and immunities of a limited liability company for profit. I further declare that the following articles shall be the charter and authority for the conduct of business of such limited liability company.

ARTICLE I NAME AND PURPOSE

The name of the limited liability company shall be Auerbach-Myers Naples Park One, LLC (the "Company") and the nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which companies may be organized under the Florida Limited Liability Company Act (the "Act").
