ARTICLES OF ORGANIZATION OF NIMBUS INVESTMENT LLC

The undersigned, being the manager, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act. Chapter 608, Florida Statutes, does bereby adopt the following Articles of Organization:
