ARTICLES OF ORGANIZATION OF LOKIZ, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is LOKIZ, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of LOKIZ, LLC, is 1169 Errol Parkway, Apopka, Florida 32712.

ARTICLE III - DURATION

The period of duration for LOKIZ, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

The name of the initial registered agent is ISABELLE BEAUX. The street address of the initial registered agent is 1169 Errol Parkway, Apopka, Florida 32712.

ARTICLE V - ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only if all the current Members agree to the admission of the additional members and to the terms of admission.

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a Member in LOKIZ, LLC, the remaining Members may, by unanimous agreement, continue the business of LOKIZ, LLC.

The Members shall have the power to adopt, alter, amend, or repeal regulations of LOKIZ, LLC.
