ARTICLES OF ORGANIZATION
of
JAB3705, L.L.C.

The undersigned, being a duly authorized person, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
DURATION

JAB3705, L.L.C. shall exist perpetually or until dissolved in a manner provided by law, or as provided in the Articles of Organization adopted by the members.

ARTICLE II
NAME AND PRINCIPAL PLACE OF BUSINESS

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.




