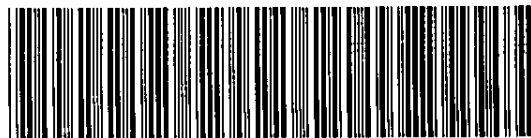

1. The Articles of Organization for this Limited Liability Company were filed on March 26, 2012 and assigned Florida Document Number L12000041771.

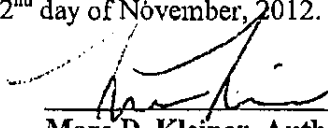
