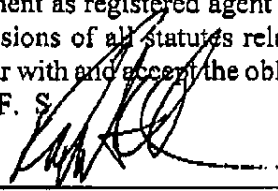

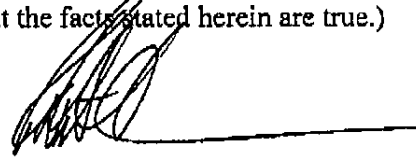
ARTICLE IV
