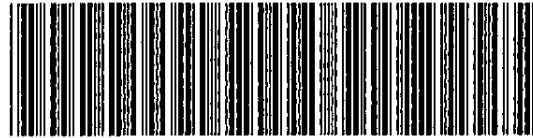

ARTICLES OF ORGANIZATION

OF

ARTICLE I - NAME


