The mailing address and street address of the principal office of the Company shall be 2950 NE 188th Street, Aventura, Florida 33180.

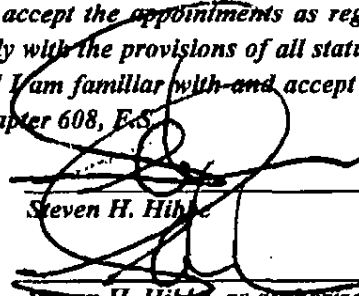
ARTICLE III- REGISTERED OFFICE AND AGENT
