**ARTICLES OF ORGANIZATION

The undersigned, NICHOLAS M. OLSON, a natural person competent to contract and a member of NICK'S LAWN MAINTENANCE, LLC, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I (NAME)

The name of this limited liability company is NICK'S LAWN MAINTENANCE, LLC (the "Company").

ARTICLE II (DURATION)

The Company shall have perpetual duration, beginning on the date these Articles of Organization are filed in the Office of the Secretary of State of the State of Florida.

ARTICLE III (POWERS)

The Company shall have all of the powers stated in the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as such chapter presently exists and may hereafter be amended.

ARTICLE IV (PRINCIPAL OFFICE)

ARTICLE V (REGISTERED AGENT)

The Company shall be managed by its members in accordance with the terms of the Operating Agreement of the Company. The name and address of the initial member is as follows:

ARTICLE VII (RESTRICTION ON MEMBERSHIP)

A member may not sell or otherwise transfer his or her interest in the Company, whether represented by membership units, certificates, or a percentage interest in the Company, until the member has complied with the restrictions, including a right of first refusal, contained in the Operating Agreement for the Company.

ARTICLE VIII - (AMENDMENT)

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.
