LOGUE, D.O., a natural person competent to contract, licensed to render services as a doctor of medicine under the laws of the State of Florida, and a member of BAY RADIOLOGY ASSOCIATES, P.L., hereby presents these Articles of Organization as the Articles of Organization of BAY RADIOLOGY ASSOCIATES, P.L. for the formation of a professional limited liability company under the provisions of Chapters 621 and 608, Florida Statutes.

#### **ARTICLE I - NAME**
