ARTICLE I

NAME OF THE LIMITED LIABILITY COMPANY

ADDRESS

REGISTERED OFFICE AND AGENT

The initial street address in Florida of the initial registered office of the Company is 8207 N. Orange Blossom Trail, Orlando, Florida 32801, and the name of the initial registered agent at such address is **DOLORES STEPHENS**.

ARTICLE V

CAPITAL CONTRIBUTIONS

ARTICLE VIII

MEMBERS' RIGHT TO CONTINUE BUSINESS

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by majority consent of all the members of the Company holding membership units of ten percent (10%) or greater.


