ARTICLES OF ORGANIZATION

OF

U.S./BRAZIL NETWORK LLC

The undersigned, acting as the organizer of U.S./BRAZIL NETWORK LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is U.S./BRAZIL NETWORK LLC (the "Company").

ARTICLE II - Address:

The mailing address and street address of the principal office of the Company is 4809 Brighton Terrace, Orlando, Florida 32811.

ARTICLE III - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

ARTICLE VII - Continuation of Business:

Unless dissolved in accordance with the Company's Operating Agreement, the remaining Members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member.
