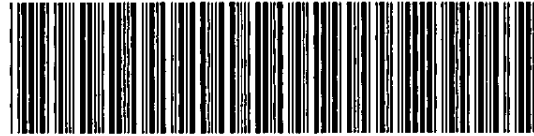

ARTICLE VIII **OPERATING AGREEMENT**



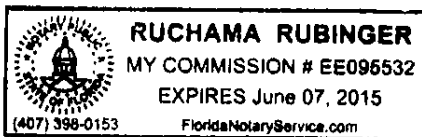


