

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be MARK MANAGEMENT GROUP, LLC, ("Company").

**ARTICLE 2 - ADDRESSES**

The principal place of business of the Company in Florida shall be 4209 N. Federal Hwy., Pompano Beach, FL 33064. The mailing address of the Company shall be P.O. Box 252, Deerfield Beach, FL 33443.

**ARTICLE 3 - EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.


